



**2022 Call for Nominations (Issued March 3, 2022)  
Grievance Committee**

A call for nominations was issued on March 3, 2022 for the Grievance Committee elections. A member shall be entitled to nominate and to vote only within the member's constituency. Nominations packages for the Grievance Committee were distributed to members in the areas where vacancies exist. **Nominations Forms must be received in the URFA office via email [urfa@uregina.ca](mailto:urfa@uregina.ca) by 4:30 p.m. March 31, 2022.**

The URFA Grievance Committee meets once each month. Complaints, appeals and grievances are handled by the Grievance Committee which is composed of representatives elected from various areas of the University of Regina, Campion College, Luther College and First Nations University of Canada. Each committee member is elected by their constituency for a **three-year term** (unless otherwise indicated) with one third of the committee membership elected each year. The term of each member is from **May 1<sup>st</sup> to April 30<sup>th</sup>**. If there are no nominations from a constituency, volunteers will be solicited. After approval by the Grievance Committee these vacancies are filled. A list of vacancies is provided below.
